OUR SERVICES ARE FREE. EACH MEDICAL MISSION INCLUDES 2-4 DOCTORS, 2-4 NURSES, 2-4 PHARMACIST TECHNICIANS, AND SOMETIMES A PHARMACIST AND AN EYE DOCTOR. THE BIBLE WILL SOMETIMES BE THE ONLY BIBLE IN THE VILLAGE WHERE THE PASTOR IS ASSIGNED (SOMETIMES IT MAY BE THE ONLY BOOK OF ANY KIND). OUR MISSIONS PROGRAM ALSO INCLUDES CHURCH

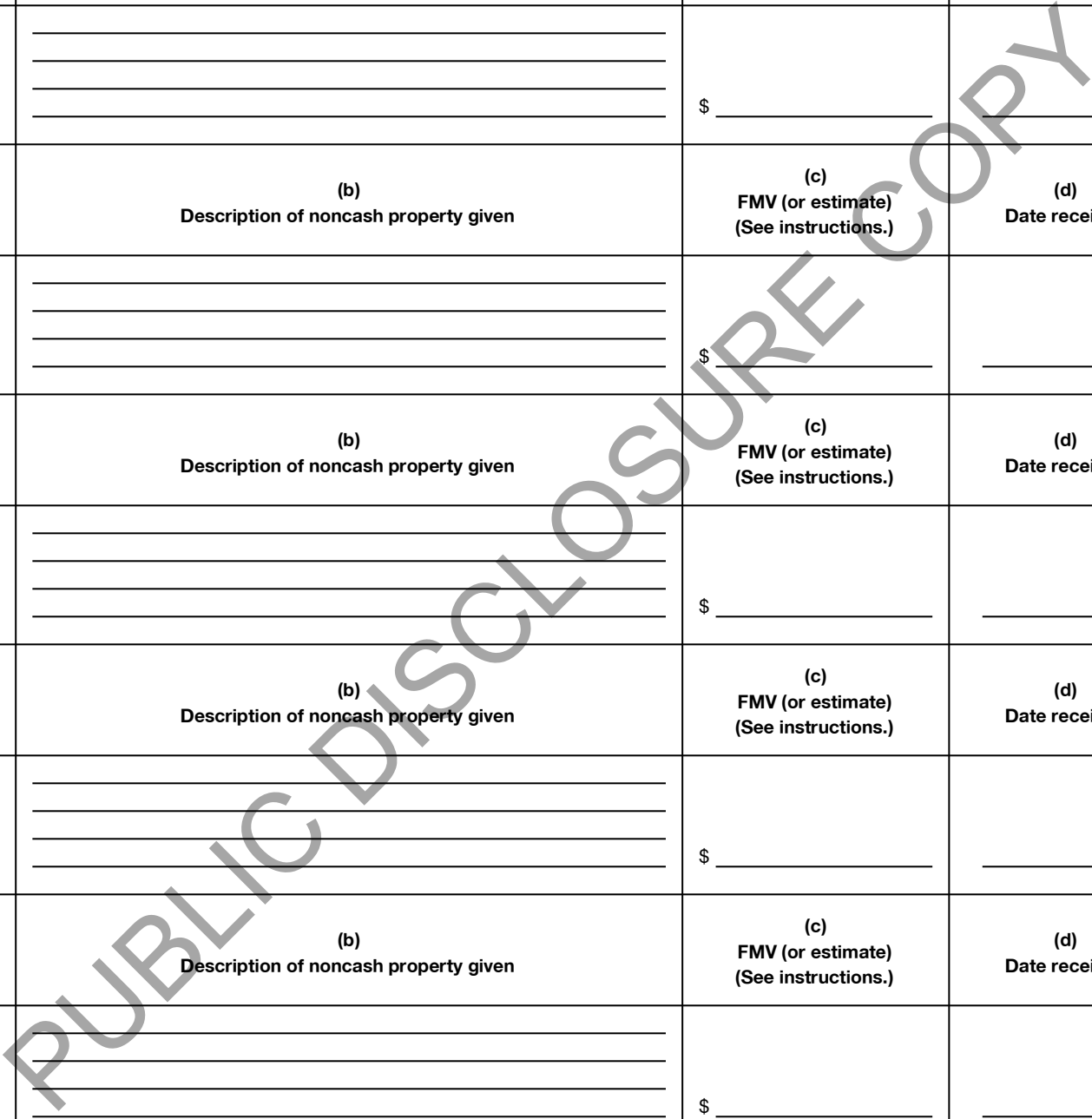

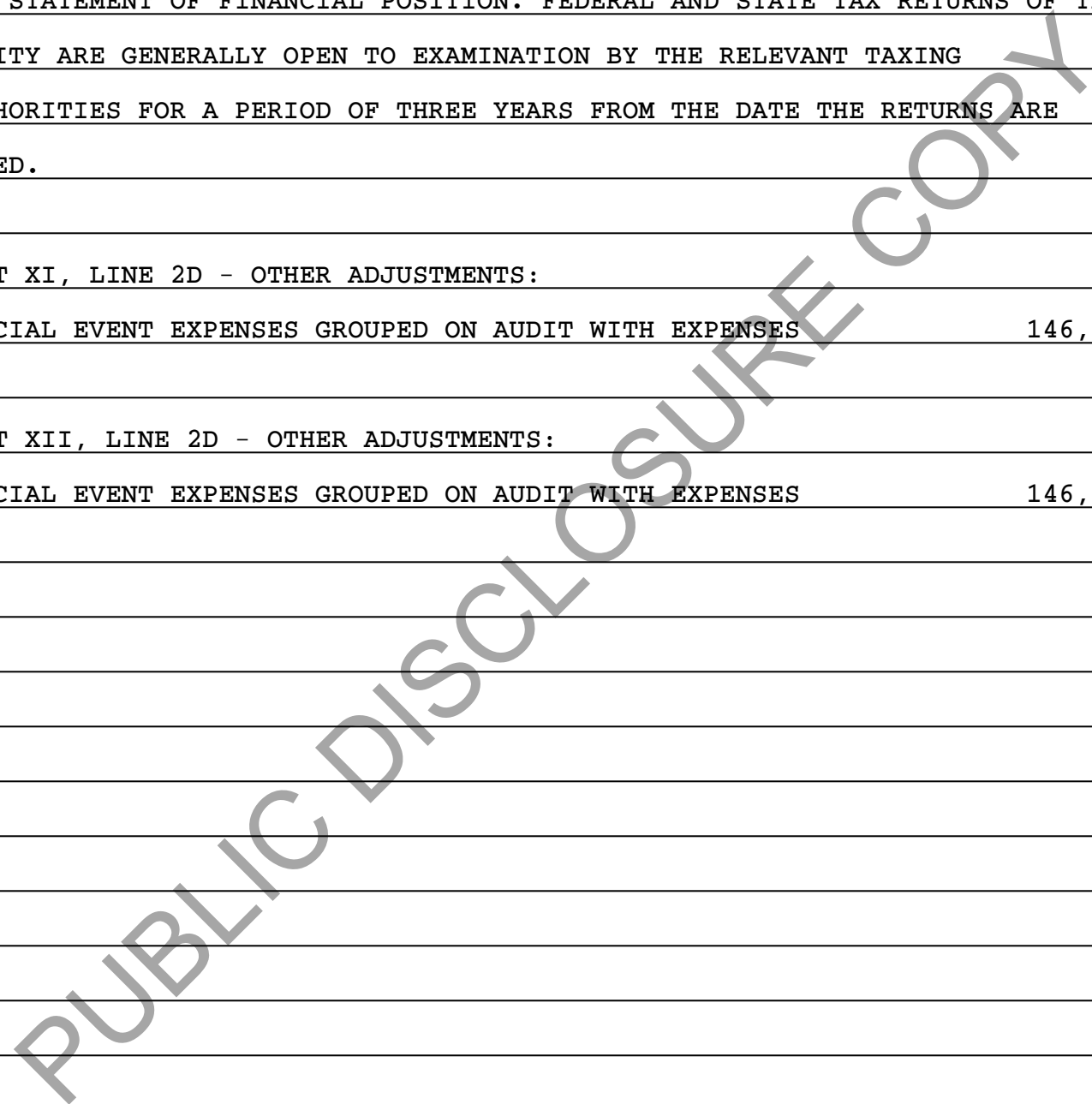

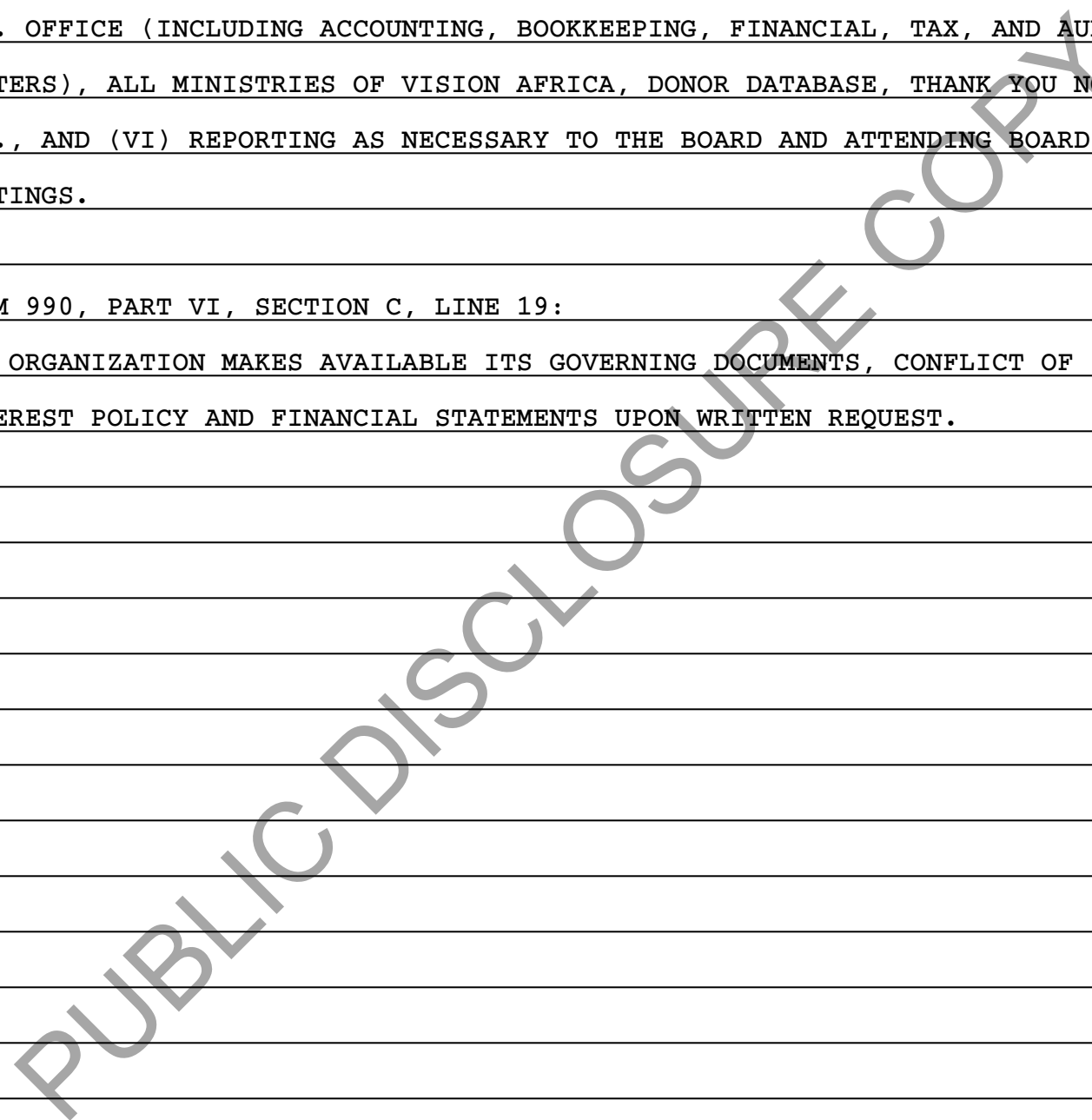
